## MT Federal Credit Union - Debt Consolidation Loan

## **CONTEST DESCRIPTION:**

Close on any eligible closed end personal loan and be automatically entered into a drawing for a chance to win 500. Two winners will be awarded. One will be announced on 2/17/22 and one winner will be announced on 3/17/22.

## ELIGIBILITY:

To enter the contest, you must be a lawful permanent resident of the United States and be 18 years or older. Employees and Board of Directors of MIT Federal Credit Union, immediate families and members of their households are ineligible to participate. Each handwritten entry will be deemed received by MIT Federal Credit Union when it is time and date stamped by MIT Federal Credit Union personnel. Only one entry per individual will be accepted. Multiple entries are void, and if a handwritten entry is declared a winner, but MIT Federal Credit Union is unable to determine the winner due to illegible writing, that entry will be disqualified. Each handwritten entry will receive one chance to win within the drawing period. All handwritten entries must be received by 4:00 pm Eastern Standard Time on the last business day of each Contest period.

# DRAWING AND NOTIFICATION:

There will be two (2) drawing held during the contest period. One drawing will be held 2/17/22 and one drawing will be held on 3/17/22. Two (2) winners in total will be chosen.
