The MIT FCU Annual Meeting was a hybrid meeting at 700 Technology Square, Cambridge, Massachusetts on **Thursday**, **April 25<sup>th</sup>**, **2024**, **at 6:04 p.m.** 

## **GENERAL BUSINESS**

## Welcome and Call to Order

Chair Blackburn welcomed members and called the meeting to order at 6:04 p.m., noting the meeting was recorded.

The 2023 Annual Meeting Minutes and a copy of the Annual Report were shared with members in attendance on the Credit Union web page prior to the meeting and available for download on the website.
